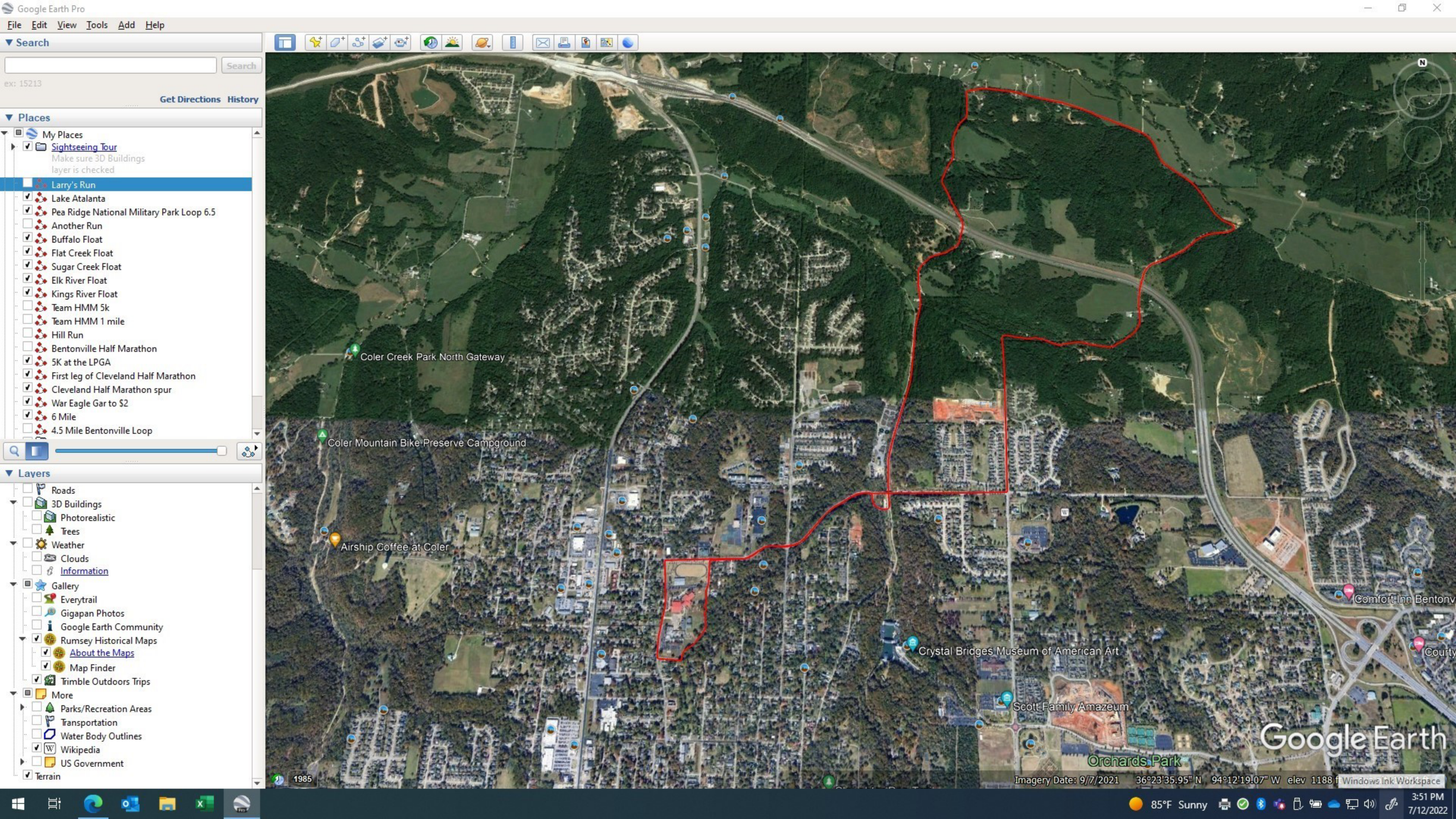

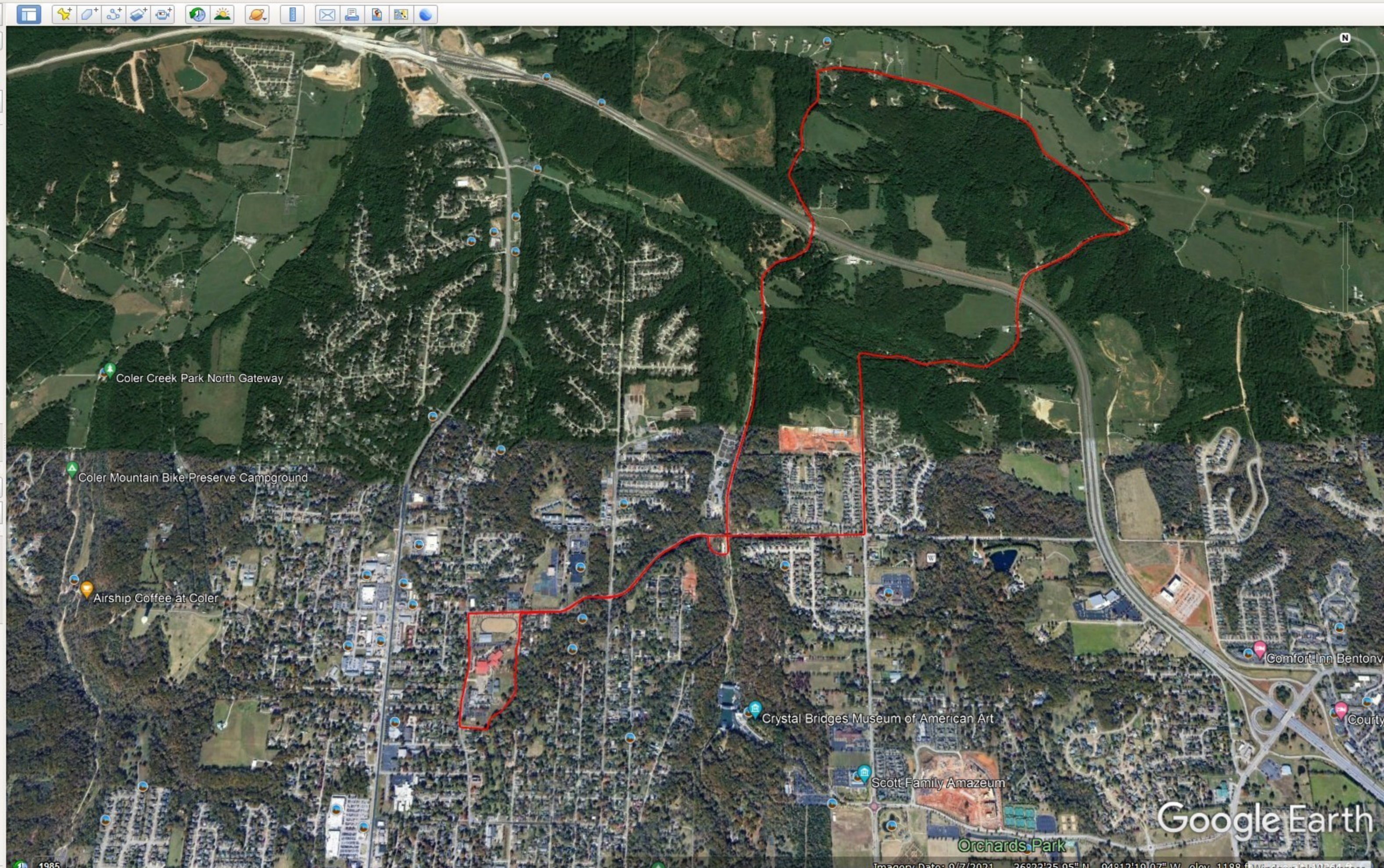

I am a property manager for Sage Partners, and we manage the property on Technology Circle in Bentonville. We are constantly having issues with thru traffic using our street to bisect the road in between Moberly and Phyllis Streets, including semi trucks and other oversized vehicles. They also use that opportunity to park in our lots and use our business' restrooms before they move their vehicles, which have been blocking our tenants' and their customers' access to their places of business. We are hoping to implement a gate specifically located at one end of our private road, not including the public thoroughfare of David Glass Road, to limit thru traffic in our business park. This also may require signage to be included at the beginning of David Glass, alongside Phyllis, to alert drivers.

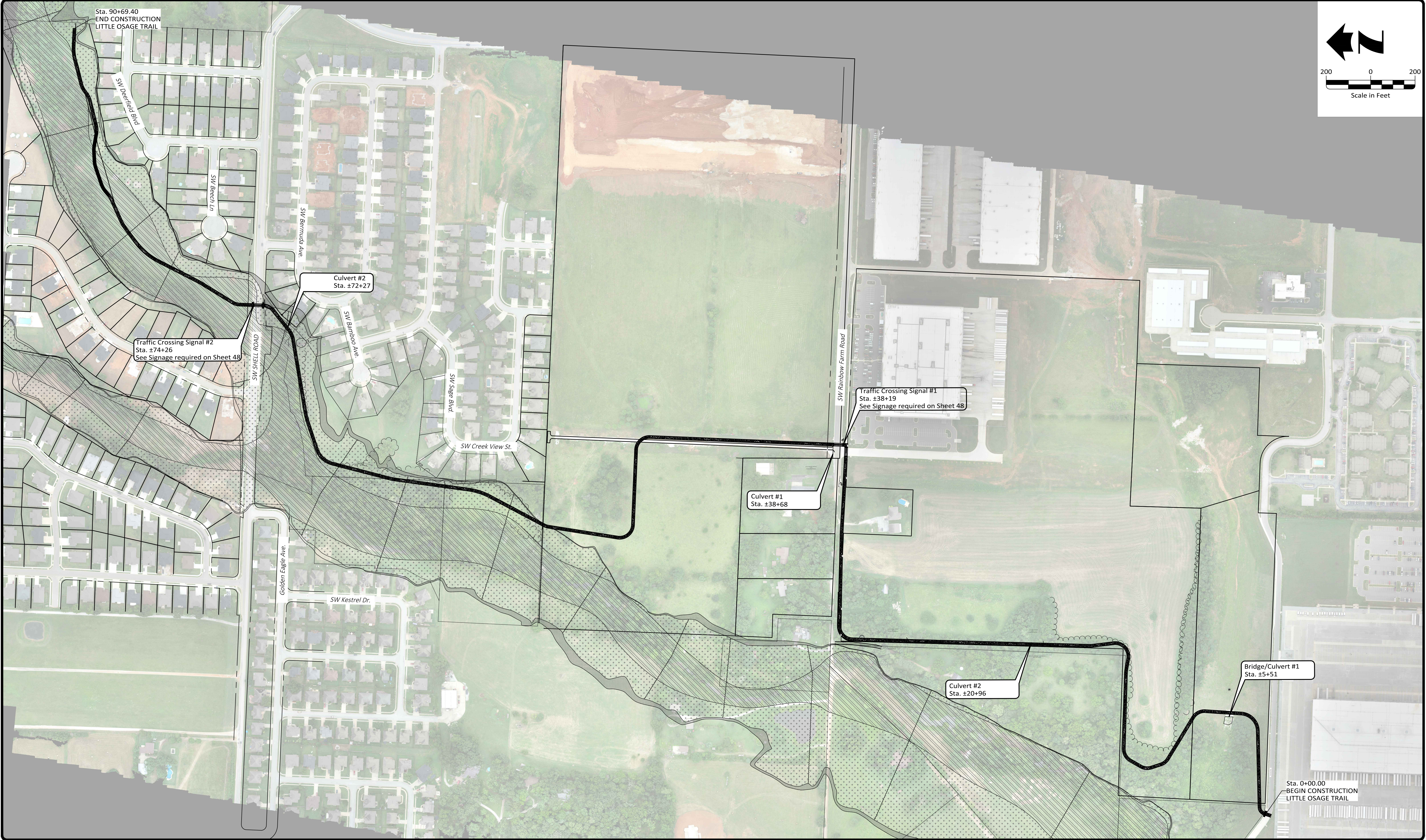
