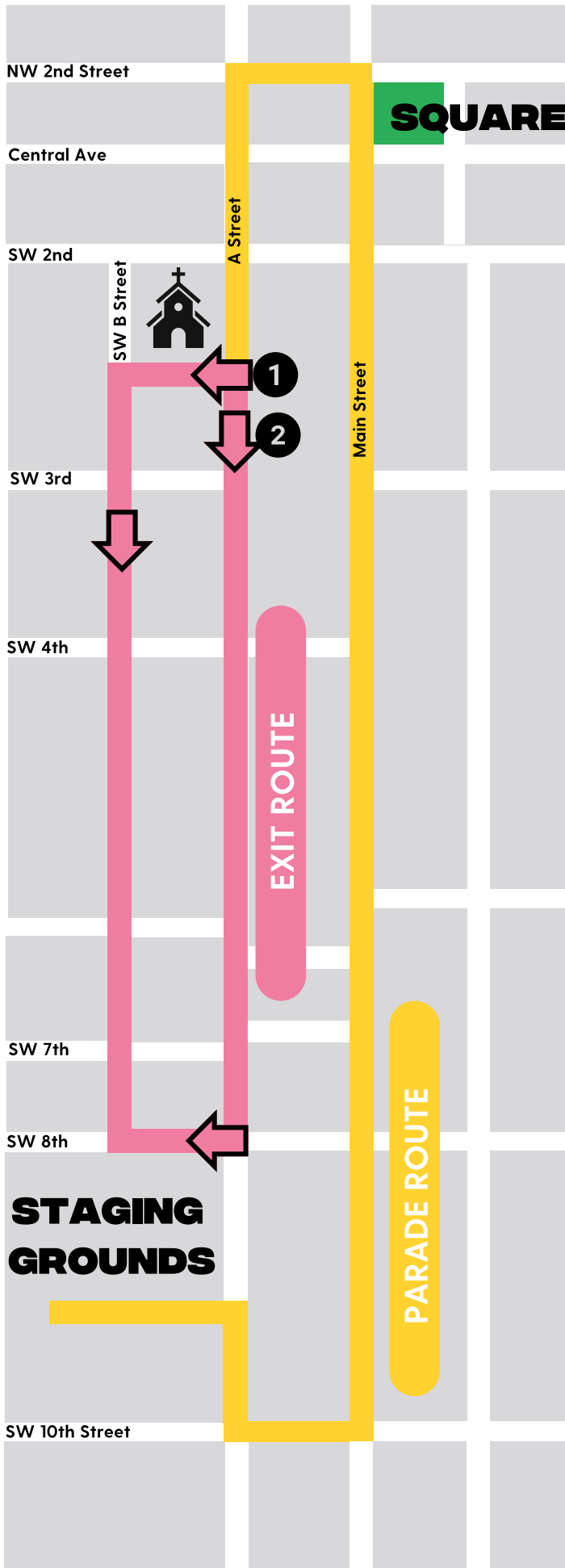
Go up Main Street to the Square. Take

Grounds.

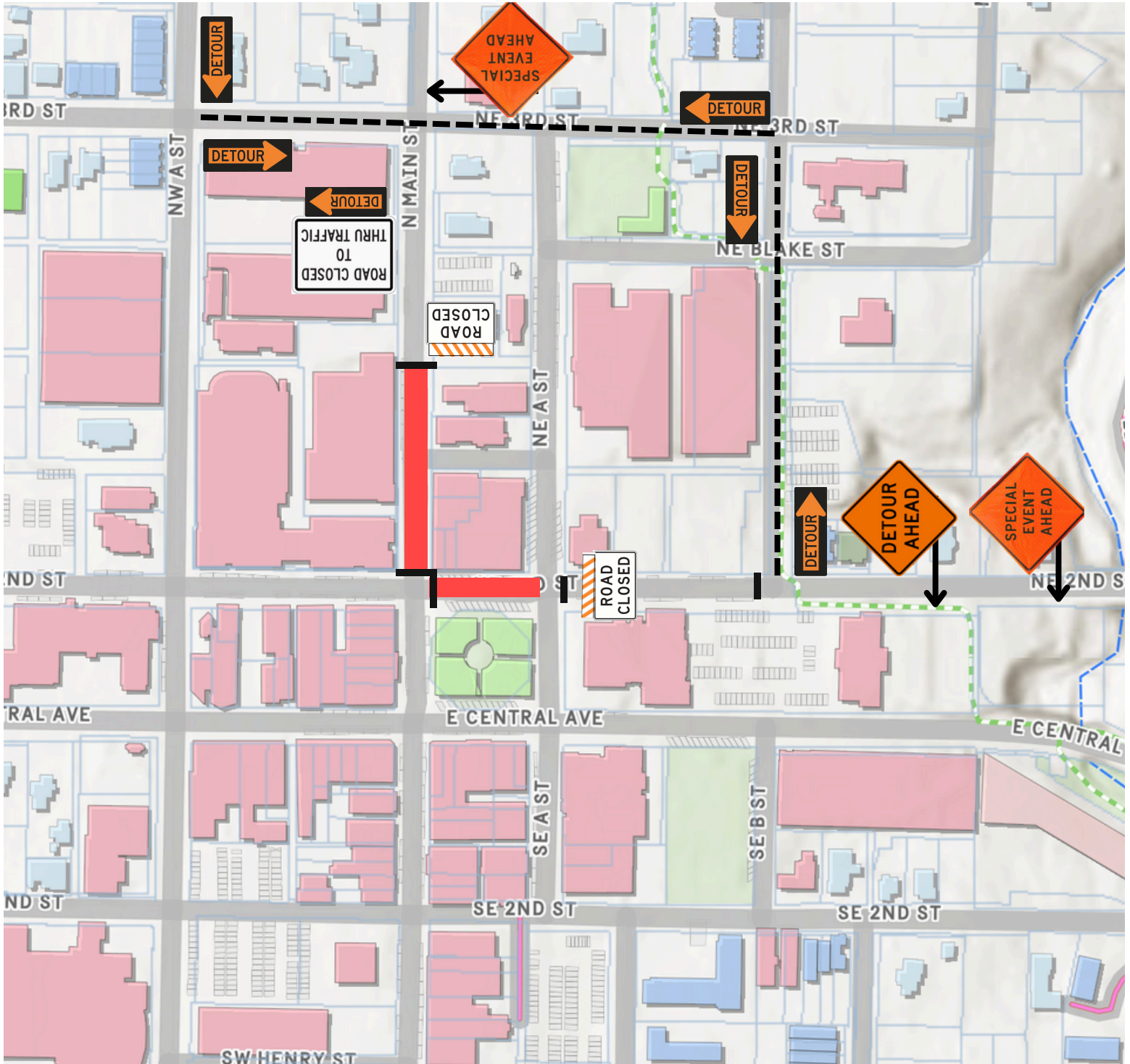
